EXECUTIVE SUMMARY

The deliverable has been elaborated within the project "Open Food Innovation University" – OFINU, No.101128855, being in implementation of the consortium of Uzbekistan, Tajikistan, European Union universities, as well as private sector partners from the involved Central Asia countries. The project is in implementation with financial support from the European Union Erasmus+ Programme. The period of the Grant agreement covers the period from 1st February 2024 till 31st January 2027.

The deliverable includes legal documents, proving the adoption of the Open University in each respective Uzbekistan and Tajikistan university, being a partner of the project. These documents are in the national languages, along with translations into English. They are appropriately divided into two parts: Part 1 – Documents in national languages; Part 2 – Documents in English.

Rivojlangan ta'lim tizimiga ega davlatlarda Ochiq universitet faoliyati keng yo'lga qo'yilgan. Ochiq universitet oliy kasbiy ta'limga ko'proq tinglovchilarni jalb etishni ta'minlash maqsadida tashkil etiladigan ta'limning innovatsion shakli hisoblanadi. Rasmiy ravishda e'tirof etilgan akademik malakalari darajasidan qat'i nazar, har kim o'qishga kirish hamda uzluksiz ta'lim olish huquqiga ega. Ochiq universitet, ta'limga ehtiyoji bor barcha insonlarga imkoniyatlar taqdim etadi. Bu ayniqsa ijtimoiy yoki moliyaviy cheklovlari bo'lgan odamlar uchun muhim. On this issue, the Vice-Rector for Academic Affairs Kh.Kh.Khonkulov spoke and introduced the members of the council to a number of works currently underway at the university to establish personnel training based on the principle of an open university (Open Food Innovation University-OFINU) in Uzbekistan within the framework of the project “101128855-OFINU-ERASMUS-EDU-2023-CBHE – Open Food Innovations University” funded by the Erasmus+ program of the European Union.

After that, the head of the university's education quality control department, A. Shamsiev, took the floor and noted that open universities are widely established in countries with developed education systems. An open university is an innovative form of education organized to ensure the attraction of more students to higher professional education. He noted that the introduction of this form of education is appropriate, taking into account the fact that everyone, regardless of the level of officially recognized academic qualifications, has the right to enroll in studies and receive continuing education.

In addition, open universities provide opportunities for all people who need education. The meeting was led by T.Z. Sultanov, Rector of the Institute, Chairman of the Council.

Secretary of the Council M.Atabayeva: In the Andijan Institute of Agriculture and AgroTechnologies, it is planned to establish an Open University within the framework OFINU (Open Food Innovation University) project of the European Union Erasmus+ program implemented in the Institute in 2024-2027.

In countries with a developed educational system, the activity of open universities has been widely established. The Open University is an innovative form of education, which is organized in order to ensure the attraction of more students to higher professional education. Everyone has the right to study and continue education, regardless of their officially recognized academic qualifications.

Open universities provide opportunities for all people with educational needs. This is especially important for people with geographic, social or financial limitations. In a rapidly changing labor market, the need to acquire new skills increases. Open universities help meet this demand, as well as create opportunities for upskilling and retraining.

For this purpose, the project of the concept of the Open University was prepared and presented to the Council for discussion, taking the organizational documents of the open university that has been operating for a long time at the Latvian University of Life Sciences and Technologies as an example.

In connection with this issue, the Vice-rector for educational affairs, prof. **M.M.Atajanov** spoke. Open universities expand educational opportunities, allowing everyone to choose their own educational path. In Uzbekistan, special educational programs are developed for different social groups, which ensures social equality. It creates opportunities for workers and students to acquire new skills, increases their competitiveness in the labor market.

Open universities support modern technologies and make educational processes more interactive and effective. It helps to solve social problems through education, increases knowledge and skills in society. Open universities support

research and promote innovation. Open universities in Uzbekistan allow integration into the international education system and exchange of experience on a global scale. Open universities also provide educational programs for teachers, which increases the quality of education.

Chairman of the Council T.Z.Sultanov: In the open university, based on the suggestions of the audience and the possibilities of the institute, training courses are organized as much as possible in the form of modules in terms convenient for everyone. That is, students who are mainly receiving theoretical education and listeners with practical experience learn subjects together and help each other, theory and practice are combined in education. At the same time, the trainees make payments corresponding to the credits allocated for the subject, receive theoretical training, and at the end of the course, they receive a certificate for the subject modules they have mastered. The credits earned by the students will be recognized by the university, and by summing up the credits they have accumulated in the courses over the years, it will be possible to receive a diploma by studying the last semester at the university. This approach makes it possible to further increase competitiveness and employment potential in the labor market in the future for those who have entered the labor market. Based on the above, he asked the members of the Council to approve the Open University concept.

Participated in the discussion: Associate Professor A.Akhmadaliev, Dean of the Faculty of Silk and Processing of Agricultural products, Associate Professor Kh.Baratov, Vice-Rector for Finance and Economics, expressed their opinions on the discussed concept and supported the approval proposal.
